Oslo is world's first capital to divest from fossil fuel



ICLEI member Oslo (Norway) is the first capital city in the world to commit to pulling all investment from the fossil fuel industry. A total of €6.4 million of coal investments from Oslo council's pension fund will be moved out of the sector and invested elsewhere

Oslo's finance commissioner Eirik Lae Solberg said: "We are pulling ourselves out of coal companies because power generation based on coal is one of the most environmentally harmful in the energy sector. We want to use our investments to promote more environmentally-friendly energy and a more environmentally-friendly society."

The Norwegian announcement came only weeks after 1,000 protesters took to the streets of Oslo demanding the action on Global Divestment day, held on 13 February. The pledge has come amidst a global push for a <u>Fossil</u> <u>Free</u> future, with more than 40 cities including ICLEI member <u>Orebro</u> (Sweden), and over 100 educational institutions, religious organisations, foundations and other institutions taking part.

Freiburg's solar village shining bright after almost 15 years

ICLEI member Freiburg's (Germany) self-sustaining village, Solarsiedlung (Solar Settlement), is going strong after almost 15 years and is still producing four times Settlement), is going strong after almost 15 years and is still producing four times the amount of energy its residents consume. The community achieves this through its smart solar design, which is embedded within the architecture. This means that the photovoltaic panels are always facing the right direction, and can increase in size when the sun dims.



59 homes have been occupied since the community's construction, which ran from 2002 – 2005. The settlement generates 420,000 kWh of solar energy from a total photovoltaic output of 445 kW peak per year, resulting in around 200,000 litres of oil and 500 tons of CO2 saved annually. The space is also car-free thanks to a large underground car park which houses 138 vehicles, and due to a well-organised carsharing system.

At the heart of the village is the Sonnenschiff (Sun Ship) which, as a large commercial space, acts as a service centre for the community. It is home to a rooftop garder, and additionally works as a sound barrier for the residencies. It is the first commercial <u>PlusEnergy</u> (a term coined by the architect Rolf Disch for buildings that produce more energy than they use) building. The space has been the recipient of many awards over the years, including the German Sustainability award, the Global Energy Award and the European Solar Prize.

Stockholm to build car-free parking lot



Stockholm's (Sweden) new parking lot will noticeably be lacking one element: cars. The new lot will, instead, house 700 bikes. "The city of the future is not one built around the car as a means of transportation," says Roger Mogert, City Planning Commissioner for Stockholm. "This requires that we make it easier to travel by bike, and of course safe and efficient parking solutions are one step towards that goal.

The covered garage is fully designed for cyclists: instead of doors with handles, entrances will automatically slide open so cyclists can ride in directly from the adjacent bike path or street; a bike repair shop will allow cyclists to access services where they park; and changing rooms will provide riders with repair shop will allow cyclusts to access services where they park; and changing fooms will provide neers with space to change and shower, with lockers for storage. "A car park requires very large surfaces for access, and ramps only used by cars," says Rahel Belatchew Lerdell CEO of Belatchew Architects, the firm designing the garage. "The flow of people is too small to generate any other activity except parking a car. With bicycles, on the other hand, we can create possibilities for activities like bike repair shops or smaller cafes, which in turn make a neighborhood livelier and safer."

Dubbing Berlin as "the most eco-hip capital of the world", the site offers suggestions on almost all aspects of city visiting. Namely, a myriad of accommodations and restaurants are listed, as well as categories including Organic Food, Sharing is Caring

(providing cooperative and upcycling options), Urban Gardening, Eco Fashion, and Berlin by Bike

The site also highlights the commitment of locals to ensuring a sustainable urban environment: "Berliners are using their free spaces as new opportunities to become socially engaged, promote sustainable forms of consumption and ways of living in the city that respect the future".

2. Mobility achievements in Bremen and Östersund celebrated



The cities of Bremen (Germany) and Östersund (Sweden) were awarded the 2014 Sustainable Urban Mobility Plan (SUMP) and 2014 European Mobility Week (EMW) Awards respectively at a ceremony held by the European Commission in Brussels (Belgium) on 23 March. The awards were presented by EU Commissioner for Transport Violeta Bulc (pictured) and Director-General Karl Falkenberg of DG Environment.

ICLEI member Bremen saw off stiff competition from fellow finalists and ICLEI neuroscience (Gorman) and Ghent (Belgium) to win the 2014 SUMP Award. Bremen was praised for the creative ways it employed to monitor and evaluate its SUMP, such as by providing an interactive online space where members of the public could find information and give feedback. The city also conducted an in-depth analysis of the risks and benefits of five possible sustainable urban mobility scenarios for Bremen.

New guidance available on risk and intellectual property rights

To address specific aspects of procuring innovation, two new guidance documents have been published by the <u>Procurement of Innovation Platform</u>: the first looks at risk management, while the second focuses on handling intellectual property rights (IPR). In addition to the recently published manual <u>Guidance for Public</u> <u>Authorities on Public Procurement of Innovation</u>, these detailed documents aim to make it easier for procurers to successfully manage the purchase of innovative products and services.



The Risk Management Guide helps procurers to overcome the uncertainties that can act as a barrier to procuring innovation. It offers insight into the specific risks of procurement of innovation and the possible methods to manage these risks, and is primarily aimed at strategists and public procurement officers familiar with regular procedures.

The IPR guide looks at the various ownership possibilities for intellectual property rights, showing procurers how to protect their intellectual propery whilst ensuring a sufficient incentive for companies to innovate.

4. European Mayors pledge to address climate issues



Mayors from 26 European cities adopted a joint declaration for climate action in Paris (France) in March. The commitment came during a high-level meeting, chaired by the Mayor of Paris Anne Hidalog (pictured) and Mayor Ignazio Marino of Rome (Italy). Leaders from other major cities including Athens (Greece), Brussels (Belgium), Bucharest (Romania), Rome (Italy) and Geneva (Switzerland) were all present.

In her opening comments, Mayor Hidalgo highlighted ICLEI's expertise in the area of sustainable public procurement. ICLEI Europe's Managing Director Wolfgang Teubner and Mark Hidson, the Global Director of ICLEI's Sustainable Procurement Capacity Centre, both attended the Paris meeting to offer their support.

The Paris Initiative forms part of the run-up to the next round of UNFCCC negotiations (COP21), which are due to be held in the French capital in December 2015.

Innovative financing of sustainable mobility provokes discussion among experts

European mobility and transport experts gathered in Leuven (Belgium) last month to discuss conventional and innovative ways of financing sustainable mobility. The gathering was part of a series of thematic meetings within the EU-funded CIVITAS CAPITAL project, which runs within the framework of the <u>CIVITAS Initiative</u>.



The meeting opened with a presentation by Allan Alaküla, Head of the EU-Office of Tallinn (Estonia), outlining the city's experience in making public transport free. The city provides registered citizens with a card that enables them to use public transport at no cost. This has resulted in considerable migration to the city and a subsequent rise in personal income tax revenues, which, in addition to higher parking fees, are used to cover transport costs.

Peter Defranceschi, Head of ICLEI's Brussels office and chair of the meeting, noted that what constitutes good practice is very much related to local conditions and that a one-size-fits-all solution does not exist. Particularly innovative solutions, it was concluded, need to be assessed and adapted over time.

CIVITAS launches third Activity Fund call



CIVITAS CAPITAL is supporting the take-up of sustainable urban mobility measures through an Activity Fund, offering co-funding of up to 50 percent for urban mobility projects. Funding will be made available via four competitive calls between 2014 and 2015. A sum of 660,000 is available in the third call which runs from 30 March – 6 May 2015.

The current call for the Activity Fund focuses on the use of practical tools to improve sustainable urban mobility measures. Many of the tools have been developed or used by cities within the CIVITAS Initiative, and cover a number of CIVITAS thematic areas – from urban freight logistics and road safety, to mobility management and public involvement. A number of other knowledge-sharing opportunities, such as the <u>CIVITAS placement programme</u>, are also highlighted in the call.

Montenegro, Norway, Serbia, Switzerland or Turkey. Applications should be submitted by 6 May 2015 using the online form.

Bucharest to host European SUMP conference

Under the theme of 'sustainable mobility for everyone', the European Platform on Sustainable Urban Mobility Plans (SUMPs) is organising the second European Conference on SUMPs in Bucharest (Romania) from 16–17 June 2015. The conference will look at tackling social exclusion through transport planning, improving transport affordability, and enhancing accessibility to jobs and services. Thematic working groups will also explore strategies for the development of mobility plans within different budgetary contexts. Technical sessions will be held to address issues such as data collection, scenario development, modelling and integrated energy planning.

As Europe's principal event on urban mobility planning, this year's conference is expected to attract 250 practitioners, policy makers and academics, exceeding the 144 delegates who attended the first edition held in Sopot (Poland) in 2014. Conference attendance is free of charge.
