# ICLEI Regional Director Wolfgang Teubner looks forward into 2015

#### Dear members, colleagues and friends,

I trust you all had a great start to the New Year and I wish you good health happiness and success



We do not yet know what 2015 will bring but it has the potential to become a decisive year for shaping the global framework for sustainable development at the local and regional level. In September, the final Sustainable development goals will

be agreed by the UN General Assembly and later in the year we hope to see an agreement on the post-Kyoto global climate regime at COP21 in Paris. Together with other partners, ICLEI is working hard to push for ambitious climate goals, a full recognition of the important role of local and regional governments, and most importantly, favourable framework conditions for local implementation.

The ICLEI World Congress in Seoul from 8 – 12 April 2015 will also be a highlight in 2015. Along with the establishment of our new Global Executive Committee and election of the new ICLEI President, it will provide a forum to discuss the future of urban sustainability with a specific focus on the Asian models and experiences.

In Europe, we are still confronted with steep challenges, with the newly elected European Parliament and the new European Commission setting jobs and growth as a main priority. It is important, however, that any investments aimed at growth adhere to sustainability criteria to achieve a low-carbon society and sustainable infrastructure development, particularly to avoid locking Europe into unsustainable solutions for years to come.

Another challenge is exhibited in the low turnout in European elections and high number of votes going to anti-European parties. The shocking assaults in Paris recently have highlighted the danger that occurs as a result of societal disintegration and segregation, and demonstrated that we need to address and manage the underlying social problems and tensions to maintain a democracy based on tolerance and trust.

Our European Membership Convention in Brussels in October 2014 noted that macro-level policies that are driven by global competition and the global financial markets are not yet addressing the societal challenges we face. Additionally, while there is no doubt that to achieve sustainable development we need innovative technologies and a move towards integrated sustainable urban infrastructure (a topic which the ICLEI European Secretariat is deeply engaged in), we must ensure that the guiding principal of this change is positive societal development.

Let's join forces in 2015 to create sustainable cities and integrated urban societies, and thereby a stronger, more sustainable and integrated Europe. I hope to meet you all at our World Congress, our European Members' Assembly or at one of the important events around COP21.

# Yerevan Municipality to run environmental education classes

# Bristol becomes 500th reporting city of carbonn Climate Registry

Through the award, cities and towns, companies, buildings and construction



Announced at the Lima Dialogues, a side event of the 20th session of the annual United Nations Framework Convention on Cimate Change Conferences (UNFCCC COP20/CMP10), the City of Bristol (United Kingdom) has become the 500th reporting city of the carbon climate Registry (cCR) – the world's leading reporting platform for local and subnational climate action. Bristol, the European Green Capital 2015, and the first UK city to report into cCR, joins the growing list of pioneering cities and numerous ICLEI members that have embraced leadership and responsibility in addressing climate change.

"Bristol aims to cut emissions by 40 percent by 2020. We've already cut emissions by 20 percent since the base date of 2005," said George Ferguson, Mayor of Bristol. "Over 50,000 Bristolians are already involved with green initiatives as we prepare for our year as Britain's first European Green Capital in 2015. We are proud of our reputation as a national and international leader when it comes to sustainable actions and we hope to influence the wider international community to do much more."

Partnered by ICLEI, C40 Cities Climate Leadership Group, and United Cities and Local Governments (UCLG), cCR is the world's leading reporting platform to enhance transparency, credibility and accountability for local and subnational climate action.

#### City of Freiburg to publish first sustainability report

The City of Freiburg (Germany) will soon publish its first Sustainability Report, a 100-page document that determines which urban activities contribute to sustainability goals, how financial resources are used, and what actions are available to thrther drive sustainable urban development. The ICLEI member has developed structures and instruments for sustainability monitoring to focus urban actions towards sustainability principles. The document will be released in conjunction with the 2015 – 2016 double budget.



Dieter Salomon, the Mayor of Freiburg, has stated that combining finance and sustainability reporting has the capacity for more comprehensive municipal actions, and is unique nationwide. He also defined sustainability in the context of Freiburg and other small cities and towns as a combination of ecological responsibility, economic growth and life quality. In order to connect sustainability goals with the new municipal budget, Freiburg 's Regional Council has selected five focal sectors and named six associated departments: children/youth & family, property and housing; social affairs and senior citizens; forestry and parks; civil engineering, and personnel.

# 3. Climate change recognised as global human rights issue



With the devastating effects of climate change apparent globally, mitigating the destructive phenomenon is increasingly being viewed as a global human rights issue. The overwhelming proportion of negative fallout from changing weather patterns will adversely affecting the world's less industrialised nations, leading many human rights advocates, including Qufam, to argue that countries with the capacity to tackle climate change have the responsibility to do so.

Former United Nations High Commissioner for Human Rights Mary Robinson has strongly argued that <u>climate change is a human rights and development issue</u> asserting that the nations most responsible must initiate progressive change in their domestic climate actions and show support for vulnerable countries. Ms. Robinson wrote: "The human cost of global warming has a name: climate injustice. The remedy, then, is climate justice. Climate justice is not justice. The human rights and development; it also involves recognising that the victims of global warming are not responsible for it, nor can their actions alone halt it."

Data obtained from the Germanwatch <u>Global Climate Risk Index</u> supports Robinson's rationale by indicating that eight of the 10 most affected countries in the period 1993 – 2012 were developing nations in the low-income or lower-middle income country group.

# **4**. 2014 revealed to be an outstanding year for wind power in Denmark

A staggering 39.1 percent of Denmark's 2014 energy consumption was windgenerated, according to the Danish Climate and Energy Ministry. In January 2014, 614 percent of Danish electricity consumption was sourced from wind. "These are incredible figures," said Climate and Energy Minister Rasmus Helveg Petersen. "We still plan to put up more wind turbines. We are moving forward and we have more targets".



Having doubled its wind power generation in the last decade, Denmark is now considered the world leader in wind-based power usage. The country affirms to be home to 90 percent of the world's offshore wind turbines and sees itself as having "found the key to stop global warming" according to Petersen.

# Procurement platform helps reduce CO2 by 65,000 tonnes



Public tenders published through the GPP 2020 project have prevented over 65,000 tonnes of CO2 from entering the atmosphere since the project began, more than the CO2 produced by 11,000 average European households each year. The project, co-funded by the <u>Intelligent Energy Europe</u> programme of the European Commission, is an online resource where low-carbon tenders are accessible to procurers and public authorities across a wide variety of topics, from the purchase of white goods to the leasing of green vehicles. The available tenders have also saved an impressive 15,000 tonnes of oil equivalent.

The savings are based on a comparison between emissions of previous, or standard, tenders and those of the new tenders that have been implemented by the purchasing partners of GPP 2020. To date, 15 tender models have been uploaded to the <u>GPP 2020 vebsite</u>, outlining exactly how different councils across Europe have implemented low-carbon tenders. These models include procurement approaches and award criteria that can be implemented by other public authorities.

The free publications, which include a guide, a life-cycle costing tool, and factsheets, provide up-to-date information and advice from experts and practitioners.

presents in-depth information for public authorities and public transport operators tasked with purchasing vehicle fleets in accordance with EU legislation. Backed-up by real life examples from European public authorities, the guide shows how environmental criteria can be introduced at various stages of the procurement process. # OECD report shows economic growth not hampered by green policies



The drive towards more sustainable, less-polluting economies does not result in lower productivity or reduced economic activity, a new study by the OECD has revealed. The report shows that while countries may initially experience a fall in economic growth as companies adapt to green regulations, what follows is generally a rebound period, with companies increasing productivity through enhancing innovation and taking advantage of new opportunities opened by the tradeburgers. regulations

Although more polluting companies have generally seen a downturn as a result of national efforts to combat climate change, the shortfall in production from these businesses has been picked up by companies with cleaner-business models, meaning the net effect has been minimal.

The OECD recommends that green policies be target concerned without being overly prescriptive, allowing firms to find the best ways to embrace sustainability. "The policy message is clear: more stringent environmental policies, when properly designed, can be introduced to benefit the environment without any loss in productivity," the report states.
