Desirable:

- Experience of working on European funded projects or service contracts;
- Experience of working with local government;
- Knowledge of European policy and legislation relating to waste and resource management, and the circular economy;
- Detailed knowledge of specific material streams relevant to the circular economy at the local level, including an understanding of key barriers, stakeholders and opportunities;
- Additional European language(s).

Your position will include the following **main tasks**:

- Support the implementation European projects that support cities in implementing circular economy initiatives;
- Undertake research and support the development of publications targeted at local policy makers, including reports, guidance, policy briefs and case studies;
- Support the organisation of virtual, hybrid and in-person workshops, communities of practice and meetings that encourage people to participate, learn and network;
- Support in the identification of funding opportunities and the development of project proposals.

**We offer you** the following conditions:

- Initial 24 months contract with high potential for extension;
