## Biodiversity & Nature-based Solutions at ICLEI Europe

Urban sprawl is rapidly depleting biodiversity and degrading natural ecosystems, while poor landuse planning is resulting in social and economic issues within and around cities.

In order to create a healthy environment to live and work in, local governments must reconcile their development ambitions with nature by integrating multi-functional, biodiverse and interconnected green and blue spaces in their cities. These can act as Nature-based Solutions (NBS), tackling challenges such as poor air quality, vulnerability to climate change-related risks like flooding or heat waves, deteriorating health of citizens, and bringing urban communities closer together. As a long-term advocate of the importance of urban biodiversity

and green spaces, ICLEI Europe supports local governments in embedding NBS into policies and planning processes. By working with cities to implement NBS and promote biodiversity, ICLEI Europe also helps them to reduce the impacts of climate change, thus creating a cohesive urban society and nature-positive economy.



Our experts in NBS and biodiversity offer training and technical assistance to local and regional governments and represent them in European and global policy processes in order to:

- Help bend the curve in global biodiversity and ecosystem loss with bold, effective local contributions;
- ◆ Ensure local governments play a strong political role and have a say in developing and achieving relevant policy frameworks and goals, including the UN Convention on Biological Diversity (CBD) Post-2020 Global Biodiversity Framework, the renewed "Subnational Plan for Action", the EU Biodiversity Strategy for 2030 or the European Green Deal:
- Provide high-quality technical and policy support to establish and implement systemic biodiversity and urban greening programmes and projects.

Led by the Scottish Government and its key partners such as ICLEI Europe, the UN Secretariat of the CBD, the European Committee of the Regions and the Quebec Government, the **Edinburgh Declaration** lays out biodiversity aspirations and commitments of local and subnational governments, in terms of what they can contribute and want to see in a Post-2020 Global Biodiversity Framework. Your city can show its support by signing the declaration **online**.

ICLEI Europe brought the perspective of its member cities to the <u>EU Biodiversity Strategy for 2030</u> and the <u>EU Nature Restoration Law</u> by participating in the consultation process and closely collaborating with the European Committee of the Regions. ICLEI Europe is also a driving force in the <u>transition towards a nature-positive economy</u>.

As an official global partner to the **UN Decade on Ecosystem Restoration**, ICLEI as a whole will play an active role in shaping the decade ahead to highlight the relationship of cities with nature, with significant and long-term commitments, and by connecting our constituents to the UN Decade. ICLEI Europe's **position paper on land degradation and soil ecosystems** will frame our activities.

NBS mainstreaming can be supported by **international and European Standardisation**. ICLEI Europe engages in various standardisation bodies relevant to introduce experiences and innovations of ICLEI members in biodiversity and NBS at the international and European levels, e.g. as **Chair of CEN/TC 465 Sustainable Cities and Communities**.
