Resilience and Climate Adaptation at ICLEI Europe

To create a healthy environment in which to live and work, local and regional governments must reconcile their development ambitions with adaptation to climate change. Facing increasingly frequent climate hazards means that communities need to find ways to approach disaster risk reduction and resilience-building in a collaborative and community-driven way.



In accordance with ICLEI's Global Resilience Planning Cycle, we support local and regional governments in managing new extremes, and support planning for and with communities as they aim to:

- understand shocks and stresses which may impede secure, sustainable development, and assess urban risks and vulnerabilities (Analyse);
- develop and implement options for building resilience to risks, such as floods, heat waves, droughts and more, to ensure a city can achieve its sustainable development goals (Act);
- scale up their resilience building activities, increase stakeholder engagement and link with national and international networks, campaigns and initiatives (Accelerate).

ICLEI INVOLVEMENT IN STRATEGIC FRAMEWORKS

The **European Urban Resilience Forum (EURESFO)**, is a joint initiative between ICLEI Europe and the European Environment Agency. For more than a decade now, EURESFO has offered a unique exchange platform where city representatives and stakeholders from various local and regional institutions come together to discuss strategies and actions for adapting to climate change and building urban resilience.

ICLEI is a core partner on <u>Making Cities Resilient 2030 (MCR2030)</u>, an initiative that works to reduce disaster risk in urban areas. ICLEI Europe is also Co-chair of the Regional Coordination Committee in Europe and Central Asia.

The ICLEI Ukraine Roadmap for Post-conflict Resilience and Recovery operates as an overarching framework for supporting Ukrainian cities in achieving their sustainability and post-war recovery targets. It also establishes the grounds towards realising cities' demand-led war fragilities, and develops a mechanism for empowering governance decentralisation efforts. This will help shift investments from a humanitarian response into energy, reconstruction and human security urgent needs, together with strategic planning for long-term opportunities in achieving Climate Neutrality, Adaptation and Resilient sustainable development in association with the European Local Green Deal (LGD).
